2013 MiOTA Conference Highlights

This year we offered 44 different sessions between the two days of conference. There were 19 posters available for viewing during the session.

Some of the changes to this year's conference included:

- 1. For Exhibitors

 - b. Breakfast and lunch both days
- 2. For Registered Attendees
 - a. Breakfast and lunch both days
- 3. For Presenters
 - a. Half price registration if attending sessions

Thank you to those who took the time to complete surveys at this year's conference. Your responses indicated that 91% felt the sessions offered were at the "just right" learning level. Also, attendees appreciated the opportunity to have meals available for their dietary restrictions with the exception of dessert items and snacks.

Areas for improvement included better scheduling of sessions. Due to the unexpected high rate of attendance we found that some of the rooms became overcrowded. It is difficult to predict which sessions will be of interest to attendees. The conference planning committee will determine ways to prevent this problem for next year.

Lastly an area for improvement is related to the website. Our goal for next year is to offer on-line registration for conference and membership and update the website with a member's only page. Also through the evaluations; it has come to our attention that the old MiOTA website is still accessible via some alternative search engines. We are in the process of removing the old site from those search engines.

We look forward to seeing you next year at the conference which at the Lansing Convention Center October 11th and 12th, 2014. Mark your calendars.

Finance Report by Denise Justice

Conference this year was very well attended by members and vendors. Not only do our members and vendors obtain increased knowledge but MiOTA gains financial support. Over the years our conference has been profitable for our organization. Our recent history is charted below.

For this year's conference we had an actual registration income of \$27,350. Our goal for income was \$28,000. We almost met this goal. In terms of actual exhibitor income we earned \$17,585. Our goal was \$16,500. We exceeded our goal. The expenses of conference to date are \$4,782. This does not account for the rental and food expenses. Our projected expense for conference this year was \$19,955. We are awaiting the final invoice from the hotel.

MiOTA has a student scholarship program now. This year at conference we announced the first recipient, Erica Frederick. How exciting that our organization is now able to offer a scholarship program. Investing in students means investing in the future of our profession. Occupational Therapy within the state of Michigan is growing.

ADVOCAY REPORT by Denise Hoffman Director of Advocacy

"If you don't like something, change it, if you can't change it, change your attitude." Maya Angelou
The past year has challenged our profession with many unexpected changes that have lead us to question, discredited, and
deflate our passion about health care and our craft. Therefore, now more than ever, we as a profession need to collaborate
and advocate for change, awareness, and validation of occupational therapy. As a profession with over 5000 clinicians in
Michigan, we CAN impact legislative changes, proposals, and interpretations. However, we are not naive about
something's that cannot be changed such as EMR requirements, so, embracing these changes empowered with education,
support, and grace will create a more fluid transition of effectiveness, and compliance.

TOGETHER WE CAN MAKE A CHANGE... This year we worked together and were successful with the following changes...

- 1. Office of Regulatory Reformed (ORR) has removed OT of the list to de –license the profession
- 2. Capitol Hill Day in May 2012 had over 70 OT's in attendance and was successful with communicating to our consistent the concerns of our profession

TOGETHER THERE IS MORE CHANGE TO DO... With that being said there is still much to do... the following are the top areas we still need to advocate for and plan to change over the next year:

- 1. Autism Bill: effective October 2012 included OT for all ages (except those with self funded private insurance plans), however an addendum April 2013 removed OT from coverage for children birth 5 y/o with Medicaid = 2013/2014 GOAL: secure OT coverage for all children birth 5 y/o despite insurance coverage
- 2. ORR proposal regarding de licensure still has the OT Board as potential means to disseminate, despite removing OT off the list of de licensure = 2013/2014 GOAL: get the ORR to remove off the proposal disseminating the OT Board
- 3. Telehealth Bill passed October 1, 2013 but OT is not directly referenced as a coverable discipline = 2013/2014 GOAL: change the interpretation of the bill to reflect OT coverage
- 4. Medicaid (specifically Meridian Health) is not covering OT treatment (or at least in very limited quantities) = 2013/2014 GOAL: to increase Meridian's understanding on the role of outpatient OT feeding, motor skills, and other sensory based treatments and that they are not covered in school, therefore should be a covered benefit for outpatient therapy
- 5. Medicare is not covering compression garments = 2013/2014 GOAL: compression garments will be covered by Medicare

Lastly, the ACA is here and we need to embrace this change together. I will leave you all with a personal challenge to make a change... stand up and support one of these platforms. Legislative changes are dynamic and always evolving, therefore if a new "hot" item is release and needs immediate attention this paradigm will shift attention as needed. Here is how YOU can make a difference and change...

- 1. Email feedback on common denials by Meridian these will be tracked to facilitate what direction OT's need to take to educate Meridian in upcoming meetings, contact dhoffmanot@gmail.com
- 2. Provide feedback on how many children in your practice with Medicaid or self funded plans will not be covered under the Autism bill 's current definition ,contact dhoffmanot@gmail.com
- 3. Interested clinicians who want to start billing with telehealth send your information to joel.m.phillips@wmich.edu
- 4. Clinicians providing feedback on how many clients are not getting lymphedema services because they cannot afford bandages, contact dhoffmanot@gmail.com

Joining the advocacy team or supporting the team with emails will initiate OT's collaborative process towards change. We will not be silent, and we will work together as a profession to make a difference... it is our right, obligation, and passion to make a change.

2013 Lyla M. Spelbring Endowed Lectureship

On Saturday, September 28, 2013 Eastern Michigan University's School of Health and Human Services Occupational Therapy Program hosted the third annual Lyla M. Spelbring Endowed Lectureship and Conference for over 120 participants. Established in 2011, the lectureship was inspired as a celebration of the legacy of Dr. Spelbring.

Lyla was a national and state leader in occupational therapy, whose mentorship, scholarship, and civic engagement were exemplary. She served in the military during three conflicts, headed the University of Michigan's Occupational Therapy program, and was the Director of the OT Program as well as the interim Dean of the College of Health and Human Services at Eastern Michigan University until her "retirement". Her service to her profession included a long-standing relationship with and a deep commitment to the Michigan Occupational Therapy Association. Lyla was President of the Michigan Occupational Therapy Association from 1959-196169 to 1971. Her work to further the profession was recognized with many national and state awards. She was given the MiOTA Distinguished Service Award in 1970, the Award of Recognition in 1984, and was named to the Roster of Fellows in 1991. She received the American Occupational Therapy Association Award of Merit in 1971, was named a fellow of the American Occupational Therapy Association in 1989.

This year's endowed lectureship speaker was Suzanne Peloquin, OTR, Ph.D., FAOTA, Professor Emeritus at the University of Texas Medical Branch. She presented her lecture, "The occupational therapy genius: Affirmations of our transcendent ethos." Dr. Peloquin's lecture focused on the importance of compassion and competence, as well as the combination of artistry and science, as essential components that set occupational therapy apart from other caring professions. The occupational therapist focuses on developing a therapeutic relationship, and, by building on her/his client's competencies, helps to recreate tge client's occupational life. She gave numerous examples, in pictures and words, from historical archives and international modern day practice of therapists, which exemplified these ideals. She described occupational therapists as pathfinders who enable occupations that heal. They reach for their clients' hearts and hands to co-create daily lives. She compelled the occupational therapy community to embrace the genius of their tradition to improve the collective well being through compassionate, competent treatment of the individual, focused on personal dignity, competence and every day health. Area scholars and clinicians also offered an array of workshops and poster presentations as continuing education opportunities for attendees at this daylong conference.

The Spelbring Lectureship was established to create a culture of life-long learning in the occupational therapy community, to support renewal of relationships with the university, as well as to provide networking opportunities to advance practice and enhance professional engagement. Dr. Peloquin's thought provoking lecture stimulated conversation amongst clinicians and students, exemplifying the objectives of the lectureship.

The planning committee for the Lyla M. Spelbring Endowed Lectureship is excited to announce that Dr. Betty Hasselkus will be the 2014 endowed lecturer on Saturday, September 27, 2014. Mark your calendars and plan on attending. Registration will be available on line.

Hand SIS By: Lydia Christesen OTD, OTR, CHT

The Hand SIS Michigan chapter has just completed their fall hand conference on REHABILITATION OF THE NECK, SHOULDER AND ELBOW presented by Scott Benjamin. We are now working on spring and fall 2014 conferences. The dates and topics are: March 28; Flexor and Extensor Tendon Treatment presented by Rebecca von der Heyde and October 17/18; Neuromobilization of the Upper Quadrant presented by Paul Bonzani. We have not finalized a location for the conferences. If anyone has an interest in having their facility host the conference please contact board member (Lydia.christesen@midmichigan.org).

Also, the board has put together a preliminary questionnaire regarding fabrication and payment of orthosis. The purpose of the questionnaire is two-fold. First it is to determine how therapists in the state are billing out for fabrication of orthotics and second to utilize the information in discussions with insurance companies. A finalized questionnaire will be presented at a later date.

UPDATES FROM THE TRI-ALLIANCE EFFORTS

The most recent meeting with the Tri-Alliance group occurred on October 24, 2013. There were 2 representatives from each discipline of OT, PT and SLP present.

The meeting included a clarification of group purpose which is to support other disciplines with similar initiatives and share knowledge relative to government and reimbursement issues within the state of Michigan.

One of the recent areas that Physical Therapy has focused there initiatives within the state has been direct consumer access. Currently only two states (i.e., OK and MI) do not have direct consumer access. MPTA hopes to have a bill introduced before 2013 end of year. MSHA has received approval from the board to support this initiative. Iota has been approached by MPTA for support. MiOTA is currently in discussion on best approach to support the bill and MPTA. Discussion regarding the deregulation of OT and SLP continued as well. Currently, there appears to be no current threat for OT or SLP to be de-regulated due to the efforts of both the associations individually. However there is continued encouragement for educating legislators regarding the practices of these professions.

The group shared information on the Meridian Health Insurance reimbursement difficulties for services. Discussion was made re: OT/SLP "cut out" of services unless through the ABA with Autism bill. OT: individual patients and therapists are advocating on their own behalf and Meridian is getting frustrated. Iota lobbyist suggested we approach Meridian as a group. MPTA offered to help if needed.

BCBS issues within Michigan were discussed. MPTA is meeting next week with BCBS. OT is continuing to work on getting splint codes reimbursed.

MiOTA Master Clinician Award

The Centennial Vision has set forth parameters for each clinician to reach outside the box to promote, educate, and secure the validity of occupational therapy. He is a driven, passionate, balanced individual; to take this challenge and succeed abundantly- Joel Phillips has demonstrated outstanding leadership at Western Michigan University and creative pioneering contributions at the Family Health Center in Kalamazoo, Michigan earning his candidacy for this award "certification of appreciation".

As a clinical faculty specialist at Western Michigan University, Joel Phillips actions in and out of the classroom demonstrates outstanding leadership role. Joel has mentored hundreds of students, created community leadership integration programs with Southwest Michigan First, and has fostered countless collaboration with the academia and private practices throughout the state. Joel has found a balance with understanding technology, social media, and cutting edge treatment approaches in his classroom to advance those students with relevant "real time" learning material. Usage of a 3 dimensional computer/scanner technology to make adaptive equipment on site, facilitating an Exos sponsored splinting lab, and volunteering to maintain the OT program's web site are a few additional endeavors that has demonstrated his integrated leadership qualities. Joel is the chair of the student recognition program, and sits on additional advisory and consultative committees at the university. His drive to foster the best education for future OT practitioners to be more well-rounded, informed, and driven, is displayed by his consistent leadership actions.

In addition to his fulltime commitment to the university, Joel was driven to give back more to his profession and his community. In 2010, Joel began discussion with community leaders about affordable skilled therapy accessible to all. His pioneer work to take occupational therapy out of the academia setting, out of the hospitals, and private practices and bring it to everyone in need was the drive for this endeavor. Fast forward to May 20 I 3, Joel opened the FIRST occupational therapy department at a Federally Qualified Health Center in Kalamazoo, Michigan. Out of 7,000 FQHC's in the nation, Joel's vision demonstrated the intuitive potential; hence he was given the contract to put this dream into action. This program will serve as a model clinic for future skilled therapy FQHC's to open throughout the nation. The Kalamazoo FQHC services 50,000-60,000 underserved individuals in Kalamazoo and surrounding areas. The onsite occupational therapy clinic is open, running, and has quadrupled its growth in two months servicing the low income and disparity population. Children, youth, adults, and seniors now have access to receive occupational therapy so they too can have the "I can" motto and put their newly gained life skills into meaningful occupations and actions.

Take note from those that lead through the quietness of actions...Leader - Pioneer Joel Phillips has contributed a wealth of knowledge, direction, and opportunities for the field of Occupational therapy exuding the essence of pose, consistency, and dedication.

Roster of Fellows

Through her significant mentorship of many occupational therapy students as a professor of occupational therapy at Western Michigan University Dr. Debra Lindstrom has established a consistent record of facilitating the professional transition from student to clinician to leaders in the profession. Many of these graduates, who are now active members of MiOTA as well as AOTA, have identified Dr. Lindstrom as a key influence in their desire and interest to be advocates of their profession as well as continuing to enhance their professional knowledge and skills by enabling a path to independent learning by her skillful and influential teaching practices. She has continuously served as a role model for both her students and her peers by way of persistent advocacy for the creation and implementation of opportunities for persons with disabilities through occupation based technology and specialized programs such as Car Fit, workplace ergonomics, and occupation based orthotics and adaptive devices. Her interest in international professional development led her to international travel to develop and implement an approach to enhance clinical reasoning skills among Bangladesh occupational therapists. Her active commitment to strengthening the status of Michigan occupational therapists by way of creating the "Friends of OT" initiative has resulted in increased support for the retention of the Michigan licensure law enacted in 2009 yet now vulnerable to challenges within the state legislature. She is a consummate professional which is recognized and celebrated by her student and the clients she continues to serve as an educator, researcher, clinician, and advocate.

Angeline (Angie) Bayci is awarded the Roster of Fellows award in recognition of her outstanding contribution in both professional development and continuing education of MiOTA members. Angie Worked tirelessly to bring the Annual Conference back to the membership.
