LEADER OF EXECUTIVE COMMITTEE UPDATE

Spring Renewals

I'm hoping that as you are reading this, you are finding spring to have "sprung" so to speak. For some of us this winter - maybe all of us, really – it has been another long, cold hard winter.

Although another hard winter wasn't exactly my preference, sometimes the tough times are great in teaching. It teaches us the importance of being prepared and proactive. It teaches us how to persevere and adapt. It reminds us how thankful we should be for what we have. And, in the end, when we come through to see the first signs of spring peeking through, it teaches us the importance of reflection as we reflect on what went well and what we should strive to do better for the next winter. Of course, just because one tough season passes, we always know that the next season may bring sunny skies or turbulent weather, so we stay on our toes as we enjoy our spring.

MiOTA is working to come out of its hard winter, but we still expect some hard weather ahead. We are learning, we are reflecting, we are rebuilding and we are replanting. We are preparing for some of our largest changes yet. For MiOTA, this spring will be about a start of a process of renewal, rebirth and regrowth. Certainly, the pains and labors of growing are difficult. Growing is unpredictable and subject to outside forces; sometimes as helpful as rain and sun, which contribute to the growth. But sometimes the forces are more like hail stones; beating down with more interest in destroying than supporting. Some of our plans have already been in the works and we finally have the right resources in place to guide us forward to walking the legal tight-ropes we have been trying to cross. Some are just getting to launch.

I was fortunate to have attended the Affiliation of State Association President's (ASAP) meeting in Nashville prior to the AOTA conference. Michigan really isn't alone in the struggles it faces; nearly every state is struggling with the exact same issues as MiOTA. Although there are a few doing better, there are certainly a number who are struggling; if not more than us, as least as much as us. We were fortunate during our meetings to have a number of great presentations and opportunities to share information with one another. From networking and learning from one another, a list of new priorities emerged for our association; call it the priorities for Membership Organizations for the Next Generation if you will.

MiOTA had a head start with strategic planning, mission and vision statements prior to my meetings mid-April. We had already launched a Survey Monkey questionnaire to gain member and non-member perspectives, a membership drive with a special offer (20% off your renewal or new/returning membership dues through the end of May, no matter when your membership expires!) and a push to rebuild and improve networking with the chapter groups including reactivation of several chapters in Michigan. With the feedback received by members and non-members, we are able to make some plans on what the majority needs and wants to see. We will have more

decisions to make on the information before we can officially share our timeline, but expect the changes to be quite noticeable. Everything is up for review and discussion right now... bylaws, how we share information/communication, networking structure, mission, vision... everything. Some of it will be a challenge; we will need manpower in the form of volunteers to make things happen. We will need standing committees and we will need some specially appointed committees. We are going to ask for more help and insights from our chapters so we have a better feel for the issues around the state. There is going to be some trial and error as we test out new ideas and even retry some old ideas. We are going to have some work to do to improve how connected the Upper Peninsula and the Lower Peninsula are with one another. We may explore some collaboration with surrounding states. Every item is under scrutiny and up for debate at this point! ©

This is MiOTA's spring to regrow. We hope you will pitch-in any ideas, volunteer time or resources you feel comfortable offering to make this a new and stronger organization for the next generation of MiOTA.



Below are listed the various awards and the criteria for nomination. Please take the time to review the various awards and submit a nomination for an award this year. One important criterion is that the nominee be a current member of MiOTA

- 1. OTR Award of Excellence: To honor members of MiOTA who have made an outstanding global contribution to the profession via encouraging the desire to contribute to the development and growth of the profession, focused public attention on the scope of OT, increased awareness of OT as a health provider and as a profession whose body of knowledge and skills are innovative in research and in implementation of new approaches to increasing quality of life.
- 2. COTA Award of Excellence: Highest Association award for a COTA to honor members of MiOTA who have made an outstanding global contribution to the advancement of occupational therapy via exemplifying the highest level of technical skills and knowledge that benefit the profession of occupational therapy. Shall have served as a leader within the profession and the health care community fostering growth and development of the profession and MiOTA.
- 3. Roster of Fellows: To recognize members of the MiOTA who, with their knowledge and expertise, during their career have made a significant contribution to the continuing education and professional development of members via utilizing special skills and/or knowledge in therapeutic practice, education, research, and/or administration. Both scholarly contribution and organizational leadership will be considered.
- 4. Distinguished Service Award: To honor a member of MiOTA for extraordinary service to the MiOTA. Nominee has made continuing and outstanding contributions to the development, growth and process of MiOTA.
- 5. Certificate of Appreciation: To express the appreciation of the MiOTA to members and non-members for

- extraordinary contributions to the advancement of OT. Their efforts could include, but are not limited to: financial contribution, political support, pioneer work, or outstanding leadership role.
- 6. Legislative Award: To recognize a member of MiOTA for significant contribution in promoting OT in the political arena via assuming an active role in training and organizing occupational therapists to impact on federal or state regulations and/or policies, educating legislators of other key government officials about the purpose and function of OT, responding to requests for action from the legislative committee of the MiOTA, acting as an advocate for consumers of health care and educational services, or playing an active role in state activities related to state PACs.
- 7. Departmental Membership: To actively support MiOTA participation by recognizing occupational therapy departments in which 80% or more of the staff are members of MiOTA.
- 8. Honorary Member Award: To recognize MiOTA members who have, or are, retiring, and who have performed distinguished service in the field of occupational therapy.
- g. Master Clinician Award: To recognize members of MiOTA, who with their knowledge and expertise, have made a significant contribution to occupational therapy through a combination of some of the following: supervision of students and staff; articles and presentations; workshops; mentoring; education; therapeutic work with clients and families. As ADA Celebrates its 25th Anniversary, Legacy Bus Tour Stops Outside AOTA Conference in Nashville

July 26, 2015, marks the 25th anniversary of President George H. W. Bush signing the Americans with Disabilities Act (ADA). The law has helped create equal access for all people—regardless of age, body, or ability—and its impact can be seen everywhere from sidewalk cutouts to wider elevators that climb to the top floor. As a part of the Consortium for Citizens with Disabilities, AOTA and its members were involved in advocacy for the law from the early stages

To help celebrate the history and significance of the law, the ADA Legacy Bust Tour (http://www.adalegacy.com/ada25/ada-legacy-tour) is traveling across the country. The mobile exhibit highlights the efforts needed to get the legislation on the books as well as how the ADA continues to shape the modern world. The bus recently stopped in Nashville, Tennessee, outside AOTA's Annual Conference & Expo, where occupational therapy practitioners had the chance to reflect on how the ADA has allowed them to better help clients engage with their communities.

"The ADA has opened many doors and removed barriers for persons with disabilities and has given the occupational therapy profession an incredible opportunity to expand its reach to enable our clients to live life to its fullest," says AOTA Board of Directors member Shawn Phipps, PhD, MS, OTR/L, FAOTA. "While we have made great strides since the ADA's enactment 25 years ago, there is still so much work to be done. In the spirit of the ADA, AOTA will continue to advocate for the occupational therapy profession and the clients we serve to ensure that we continue to provide high quality services that promote full engagement and participation without restriction."

MiOTA is looking for a few individuals to run for office this year.

Communication Director: This position appoints, (with the approval of the Executive Committee) and oversees the Coordinators of the Newsletter, Website and Listserv coordinator as well as Networking Committees and the subsections of the Networking Committee (Special Interest Sections [SIS] and Chapters). They discharge the duties of the Leader of the Executive Committee in the absence of the Leader; perform other such duties as are assigned by the Executive Committee, and orient incoming elected director at least two (2) months prior to the first day of the fiscal year before the elected member assumes office.

Financial Director: This position is responsible for managing the fiscal affairs of the Corporation so that the financial resources are available to allow the Corporation to achieve its goals. They prepare the budget and present it to the Executive Committee for approval. Act in an advisory capacity to the Agent of the Corporation. Keep full and accurate accounts of all receipts and disbursements of the Corporation or delegate to an Agent for the Corporation as specified within a contract. Arrange for the annual review of the corporation accounts by a qualified accountant.

Submit written statements of financial affairs to the Executive Committee for all Executive Committee meetings and at other intervals as it determines. Review submitted Co-Sponsoring Activity with MiOTA Worksheets and Cost Projections Worksheets with other interested parties and informs the person or persons of acceptance, need for revision, or denial of the proposal. Orient incoming elected director at least two (2) months prior to the first day of the fiscal year before the elected member assumes office. Perform other such duties as are assigned by the Executive Committee.

Advocacy Director: This position is responsible for appointing, with the approval of the Executive Committee, and oversee the coordinators of Public Policy and Third Party Reimbursement, exhibit knowledge regarding current health care legislation and reimbursement issues at the State and National levels, assure MiOTA's legislative presence and integrity in health care issues at both the state and, through AOTA, at the national level, assure the involvement of MiOTA in issues that impact the reimbursement for occupational therapy services in the State of Michigan, assist the MiOTA membership in obtaining necessary information regarding laws, rules and regulations and third party reimbursement and shall serve as an avenue for the membership to bring related issues to the attention of the Executive Committee and/or Association Assembly.

If any member has interest in any of these positions, please contact the MiOTA office. To be eligible, nominees must be members of both MiOTA and AOTA registered within the state of Michigan to practice and have served on at least one committee of the corporation. A waiver of these qualifications may be granted by a majority vote of the Executive Committee. More information can be shared. Individuals may want to communicate with current officers for more in depth discussion about the positions in making a decision to be nominated for the offices. Deadline is June 15, 2015.
