## MESSAGE FROM THE CO-LEADERS OF THE EXECUTIVE COMMITTEE, BY DENISE JUSTICE & KIRSTEN MATTHEWS

Spring has sprung! Although many feel as though they "hibernate" all winter rest assured MiOTA has remained busy all winter. Below is a brief summary of the things going on in MiOTA.

1. FALL CONFERENCE - Grand Rapids: We've been planting seeds for conference this fall and we have received over 30 presentations. This years' conference is in Grand Rapids October 6th and 7th and will be going on the same time as Art Prize! Stevie Hopkins will be our Key Note Speaker this year and the 5K walk/run will occur on October 5th. Based on previous year's feedback from Exhibitors, we have changed the format of the Exhibition time to one-day only. Last year, we received outstanding feedback from our exhibitors on the great turnout they had. We are still looking for exhibitors - if you know of any exhibitors or your company would like to exhibit, please give us a call or email at the MiOTA office!

2. ADVOCACY - Advocacy efforts are blossoming as evidenced by the success with the Lansing Lobby Day

on April 22nd. Cultivation of MiOTA advocacy efforts continues as we are monitoring a variety of bills that could impact the practice of Occupational Therapists within the state of Michigan. There recently was a new draft of the Occupational Therapy Rules for Michigan by the Board of OT and we have some concerns and would like some clarification regarding the draft, so we will have a workgroup this coming month (email us if you'd like to participate) and a presence at the next State of Michigan Board of OT meeting. As some of you may know, Michigan was chosen as a state to receive a grant from the Substance Abuse and Mental Health Services Administration (SAMSA) to develop Certified Community Behavioral Health Clinics (CCBHC). The clinics are to service individuals across the lifespan, including children with serious emotional disturbances, adults with serious mental illness, those with long-term and serious substance use disorders and those with substance use disorders and mental illness. The purpose of the grant is to certify clinics, develop a prospective payment system (PPS) for Medicaid reimbursable services and prepare an application for a two-

year demonstration program of those clinics. Although SAMSA lists Occupational Therapy as a recommended provider, we are not a required provider, which is what we would like to be. We are initiating a grass roots effort to get Occupational Therapy a place at the table in Michigan. Please see the grass roots letter and intro later in this newsletter for details.

3. NETWORKING - Chapter meetings are springing up all over the state. Exciting webinars are popping up every month - a FREE member benefit.

4. LEADERSHIP - And just like there are changes in the "gardening staff" through the seasons, reorganizing and changes of the MiOTA Executive Committee has occurred as well. Kristen Clore has stepped away from the finance director position and Cindy Klinger was appointed by the MiOTA board as her replacement. We are sad to announce that Denise Hoffman will also be leaving as she is pursuing job interests outside of the state of Michigan. Kirsten is on Maternity leave with her baby, but is still helping with MiOTA stuff as needs come up. Denise attended the

Affiliation of State Association Presidents (ASAP) meeting in Chicago in April during the AOTA conference and came back with lots of great ideas. Also, MiOTA won an award at that meeting for our work so far on the Transition Planning you'll read a bit more about in the "Structure Changes" section below.

5. STRUCTURE CHANGES (MISSION, VISION, BYLAWS, **BOARD STRUCTURE) - Some** additional garden changes are expected over the next year as we plan to revise the mission and vision of MiOTA, our By-Laws, and our website / advertising services. Our bylaws committee met last month to move forward with some structural changes and the Association Assembly voted in favor of pursuing a President, Vice President, Treasurer, Secretary structure more similar to what other states have instead of our current "corporation structure" due to member comments/concerns that our current structure is too difficult to understand. We are also in the final process of launching the new Mission & Vision Campaign and you will likely see surveys through the listserv and on Facebook early this summer.

6. CALL FOR NOMINATIONS FOR 2016 ELECTIONS – The positions of Membership Director and Memberat-Large are up for re-election. If you are interested in running for either of these positions, please submit your nomination to the MiOTA office NO LATER THAN JULY 1st, 2016.

7. SPRING MEMBERSHIP DRIVE -Given the difficult financial climate in the state of Michigan our garden has had trouble growing its membership/income. The Winter/Spring season is financially the hardest for MiOTA as it is our slowest for new membership & renewals and we do not have additional supplemental income from the Fall Conference like we do in the summer and fall. We've had a number of people comment that they would like to see the Membership "discounts" again, so for the month of May, we have decided to bring back the 20% off membership dues for both renewals and new memberships. Use the discount code May2016 to get the discount if you renew online.

### Friends of OT in Michigan Political Action Committee— Spring 2016 Update

Between October, 2013 (when we re-activated the PAC) and September 2015, we had raised \$3,630.02. During the month of October, 2015, we raised another \$1,387! The goal was \$2,000 for 2015. We are close to that goal, but there is still time to meet/surpass our goal to support candidates who are in positions to positively represent occupational therapists in MI. Our "grand total" is \$5,128.02, but that has to be split with candidates throughout the state, so if we could round that total up to \$6,000, we would be better able to make contributions that would get really noticed by the candidates.

The Friends of OT in MI follow the recommendations of the **Executive Committee after** consulting with our lobbyist for which candidates to support with our PAC funds. One of the strategies that the MiOTA Executive Committee is considering this year is paying for MiOTA members who have also contributed to the Friends of OT in MI to attend fund raising events for candidates that our lobbyist, Brent Mayhr, has highlighted as good candidates for OT to support. MiOTA will have a training webinar to help interested MiOTA and Friends of OT in MI members understand the talking points for the candidate or key staff members.

We have over \$5,000, but we don't have as many donors this year as in the past. Please consider making a donation now to help support our members (which could be you if you live in the highlighted district, have contributed to the PAC and are interested) in attending the fund raising events. This year we didn't have ANY student donations (\$5 donations are very welcome), and many of our universities and colleges are not yet represented. Let's increase our contributions to position us strongly in the next election!

### Please note that our PO Box # has changed from a few years ago—the correct PO box is on the contribution form. We do still need your name, address, phone #, occupation, place of employment and employment address. Contributions can only come from individuals-not companies/organizations. This is the federal law for political action committees. We do have a Square Reader to take credit cards, but can only accept cards in person. If people are interested, we will work at having someone with a Square Reader at chapter meetings if there are people who are wanting to make donations at the meetings.

### 2016 Call for Nominations for MiOTA Office

### Description of Positions:

If you are interested in running for one of these positions, please submit your contact information, autobiography (brief and suitable for publication) and position statement to MiOTA by July 1st, 2016.

The Election Ballots will be in the Summer Newsletter. Candidates will be notified of election results within 15 days of the close of the election and membership will be notified via email blast within 15 days of the close of the election. In addition, election results will be shared at the Fall Membership Meeting at the MiOTA annual conference and in the fall newsletter, which will be released after the Annual Fall Conference. Nominees must agree to serve the position if elected. All positions are 2-year terms. Candidates must be members of AOTA, licensed in the state of Michigan and voting members of MiOTA. We ask that if elected, new officers participate in the Annual Fall Conference to allow for orientation to their position.

### Member at Large/Secretary:

The responsibilities of the Memberat-Large/Secretary include:

1. The Member at Large/Secretary is charged with representing the interests of the Members of the Corporation.

2. Record the minutes of all the meetings of the Corporation, including the Executive Committee

and the Association Assembly.

3. Maintain the history of the organization

4. Call a Special Meeting of the Corporation

5. Perform such other duties as may be assigned from time to time by the Leader of the Executive Committee

6. Act as Leader of the Executive Committee pro tem until a special election is held if the offices of the Leader and all Directors are vacant at the same time.

7. Communicate substantive changes or revisions of the MiOTA Bylaws, as approved by the Executive Committee to the Membership.

8. Orient incoming elected secretary at least two (2) months prior to the first day of the fiscal year before the elected member assumes office.

### Procedures –

a. Record minutes of the business meetings of the Corporation; retain original for Secretary's file, and send copies to the MiOTA office, Executive Committee and Association Assembly members.

b. Record minutes at all MiOTA Executive Committee, Association Assembly, and general membership meetings.

c. Maintain a current Association Assembly Mailing list.

d. Maintain the history of the organization.

e. Check and ascertain at least annually the location of all equipment and non-expendable materials; provide a dated inventory to all members of the Executive Committee and report missing or lost items to the Executive Committee.

f. Submit an annual report to the Executive Committee

g. Sign Expense Vouchers provided by the Financial Director and return to the Financial Director for signature and submission to the Agent of the Corporation for payment.

The Member at Large/Secretary is a voting member of the Executive Committee and a voice only member of the Association Assembly.

### Membership Director:

The Membership director's responsibilities are to:

1. Appoint, with the approval of the Executive Committee, and oversee the Coordinators of Recruitment, Retention and Activation

2. Appoint, with approval of the Executive Committee, the members of the Nominating Committee

3. Serve as Leader of the Executive Committee in the absence of the Leader and the Communication Director

4. Orient incoming elected director at least two (2) months prior to the first day of the fiscal year before the elected member assumes office.

5. Perform other such duties as assigned by the Executive Committee.

#### Procedure

a. Report all pertinent activities to the Executive Committee and Association Assembly.

b. Submit motions for Executive Committee and Association Assembly Action.

c. Oversee the preparation of the budget for recruitment, retention and activation and Nominating Committee and monitor expenditures of these units.

d. Recommend individuals to the Executive Committee for appointment to and oversee the activities of the following positions: Recruitment Coordinator, Retention Coordinator, Activation Coordinator, Nominating Committee

e. Assume the Office of Leader of the Executive Committee in the absence of the Leader and the Director of Communications

f. Prepare an annual report for the MiOTA Executive Committee to include, at a minimum: Activities and accomplishments, short and long term goals related to the Long Range Plan.

The House and Senate Legislators were all invited to attend our event. House Representative, John Bizon, and Senator Hoon – Young Hopgood both attended our 'meet and greet' session, whereas over 20 additional meetings occurred in the legislators' offices. As a profession, we were able to effectively communicate about occupational therapy and pending issues regarding the need for continuing education requirements in Michigan for our profession.

As many of you may know, the State of Michigan was awarded a planning grant for the Certified Community Behavioral Health Centers (CCBHC) by the Substance Abuse and Mental Health Services Administration (SAMHSA). Per the SAMSA Website: "The purpose of the CCBHC grant program is to support states to certify clinics as certified community behavioral health clinics (CCBHCs), establish prospective payment systems for Medicaid reimbursable services, and prepare an application to participate in a two-year demonstration program. Populations to be served are adults with serious mental illness, children with serious emotional disturbance, and those with long term and serious substance use disorders, as well as others with mental illness and substance use disorders."

Although Occupational Therapy is listed as one of the recommended providers in the CCBHC's, there is no guarantee we will be included as one of the providers for the programs. *We are requesting you advocate that Occupational Therapy be a REQUIRED provider within the CCBHC's.* 

#### WE NEED YOUR HELP!

Currently, MiOTA's CCBHC Workgroup has drafted a template of a letter you can use to contact your legislators to help educate them on the DISTINCT VALUE of Occupational Therapy and how our inclusion as a REQUIRED provider within the CCBHC's will enhance the team.

On April 1, 2014, the President signed the Protecting Access to Medicare Act (PAMA) into law, which included a provision authorizing a two-part **Certified Community Behavioral Health Clinic (CCBHC) Demonstration program**. The law allowed for a \$1.1 billion investment in community based mental health services for Medicaid recipients – the largest of its kind for several generations - over the course of the demonstration.

In October of 2015, SAMHSA and CMS announced that 24 states have been awarded one-year CCBHC Planning Grants. <u>Michigan was one of the states awarded a planning grant</u>. Recipients will be required to certify community behavioral health clinics, solicit input from stakeholders, establish prospective payment systems for demonstration reimbursable services, and prepare an application to participate in the demonstration program. Eight of these states will then be selected as demonstration sites for enhanced federal matching funds based on payment via a Prospective Payment System (PPS) for Medicaid services during the CCBHC two-year Demonstration.

The ultimate Demonstration application will be submitted to SAMHSA by each State Planning recipient by October of 2016 in order to be considered to participate in the CCBHC demonstration program. CCBHC Implementation will begin in January of 2017.

Occupational therapists were listed among the suggested staffing for CCBHCs under section 1.b.2 of the SAMHSA CCBHC criteria<sup>1</sup>. MiOTA strongly recommends that occupational therapy practitioners be a required part of the CCBHC interdisciplinary team. Occupational therapy practitioners have an essential role to play in the full arc of services provision: evaluation, the development of a plan of care, and the implementation of many of the other services required by Congress.

## Occupational Therapy, which has its roots in psychiatry, is an essential addition to the state CCBHC initiative because OT Practitioners:

- 1. Are trained to assess cognitive and functional impairments and risk;
- 2. Help span the boundary between the behavioral and medical fields—a key objective of the CCBHC initiative;
- 3. Can assess functional cognition, which is the way an individual utilizes and integrates his/her thinking and processing skills to accomplish everyday activities. The OT practitioner can advise adjustments to the care plan if an individual's cognitive deficits reduce their capacity to understand their diagnosis, effectively participate in care planning, take medication, attend routine appointments, or successfully engage in interventions (especially the many modalities rooted in cognitive behavioral therapy);
- 4. Help people across the lifespan with serious mental illness develop day-to-day independent living skills and improve their functional capacity

As your constituent, I urge you to ask DHHS to include occupational therapists as **required staff** for the Michigan CCBHCs. Even better, urge DHHS to have occupational therapists on the planning committee for this grant. To date, there has been little transparency in the process, and the essential practitioners are not sure where we stand.
